

## From the President



Several months ago, a colleague from another state asked me to describe the Austin Peay community. I relished the opportunity, because that word—community—is one of this institution's core values, and it's something we take seriously here. Our faculty and staff are vigilant about finding new ways to enhance this region, and in this issue of "Austin Peay: The Magazine for Alumni and Friends," you'll see what we're doing to improve our local and global communities.

I was particularly proud of how the University responded to the recent total solar eclipse, turning that historic experience into a community-wide and regional educational event. On Aug. 21, NASA

scientists, along with children attending NASA Space Camp, converged on the Austin Peay farm, where they observed the eclipse and conducted experiments. The University's observatory also provided a NASA live feed, allowing people across the country to watch the eclipse through the safety of our telescopes. The Martha Dickerson Eriksson College of Education presented educational seminars, training local teachers how to include lessons about the eclipse in their classrooms, and the APSU College of STEM (previously the APSU College of Science and Mathematics) hosted several eclipse-themed events, including community lectures over the summer, an educational fair and a viewing party at Fortera Stadium.

This university also continues to enrich the cultural life of our community through its Center of Excellence for the Creative Arts. The programs and outreach provided by the Center improve the quality of life for citizens in this region, and the Center is a highly regarded incentive for companies looking to relocate into areas where their employees will be happy to live and work. Dr. Janice Crews, an experienced and respected arts administrator, began serving as director of this program in January, and she has embarked on a new rebranding campaign to let the public know that the Center's events are open to everyone.

This year, the University also embarked on a major project to restore and preserve the native grasslands that once flourished in this community. In the last 200 years, more than 99 percent of the region's grasslands have disappeared. In 2017, Dr. Dwayne Estes and the APSU Center of Excellence for Field Biology launched the Southeastern Grasslands Initiative (SGI). This nonprofit, based at Austin Peay, is a collaborative effort of the Botanical Research Institute of Texas, the North Carolina Botanical Garden and Roundstone Native Seed. According to Dr. Estes, the program's executive director, the SGI will now use a combination of scientific research, public education and the administration of grants to help restore the Southeastern grasslands, "the most imperiled ecosystems in eastern North America."

Members of our community also demonstrate their commitment to our University in a variety of significant ways. A few days ago, I turned onto University Avenue and noticed the beautifully landscaped medians with the letters "AP" greeting me as I drove toward the University. The Hand Family Companies—longtime supporters of this institution—adopted this stretch of green space as part of Clarksville's adopt-a-plot program so that the view of the primary entrance to the campus would be memorable and welcoming. The Hands recognize the important role Austin Peay plays within this community and are valued partners.

Whether I'm referring to the efforts of our faculty, staff and students on behalf of our community or the efforts of our larger community members on behalf of our University, I'm proud of the commitment to embrace the core value of serving one another. I hope you enjoy this issue of "Austin Peay: The Magazine for Alumni and Friends."

## GOVS GIVE Campaign Surpasses Goal

Last spring, in conjunction with the University's 90th anniversary, the APSU Advancement Office hosted a 90-hour giving event, Govs Give, with the goal of raising \$90,000 for the different colleges' Funds of Excellence. These are innovation funds that allow deans and directors in academic and student areas to provide students with the tools and opportunities they need to succeed. The campaign raised more than \$148,000, with donations coming in from as far as Canada and Australia.



## **CHANDLER APPOINTED DEAN**

of Martha Dickerson Eriksson College of Education

In April, Dr. Prentice T. Chandler was appointed as the new dean of Austin Peay State University's Martha Dickerson Eriksson College of Education. He replaced Dr. Carlette Hardin, who recently retired as dean after serving in that position since 2010.

Chandler previously served as associate professor of education and associate director of teacher education and leadership at the University of Cincinnati, Ohio, where he oversaw programs in middle childhood education, secondary education, special education and educational leadership. As an educator, Chandler taught courses in social studies education, diversity and critical race theory. Prior to Cincinnati, he served as department head of secondary education and a professor of secondary history and social science education at Athens State University, Alabama. His book, "Doing Race in Social Studies: Critical Perspectives," was published in 2015.

## **NEW BOOKSTORE**

APSU Opening Barnes & Noble Campus Bookstore on College Street Austin Peay State University's 10-year strategic plan calls for creating "a vibrant downtown for a traditional college town experience," and that goal will receive a major boost when the institution opens a 13,000-squarefoot retail bookstore and coffee shop at the corner of College and Fourth streets.

The University is partnering with national book retailer Barnes & Noble to operate the campus bookstore, which will be open to the public, selling children's books, trade books, best sellers, office supplies and Austin Peay branded merchandise. The venue, set to open by the fall of 2018, will be similar to the Vanderbilt University Barnes & Noble on West End Avenue in Nashville, with a Barnes & Noble Café that also will be open to the public.

## SCHOOL OF NURSING

Receives Fifth Grant to Help Combat Breast Cancer

For the fifth year in a row, the Greater Nashville Affiliate of Susan G. Komen for the Cure has awarded a grant to the APSU School of Nursing and the Montgomery County Health Department, providing more than \$200,000 in that time for free mammograms and breast exams.

This year, the Nashville Komen affiliate presented the two organizations with a \$42,930 grant to help women who are uninsured and 40 years of age or older receive a free mammogram and breast exams through the Montgomery County Health Department.

Wins National Awards

The All State, APSU's student newspaper, earned two national Apple Awards at the Spring National College Media Convention in New York City on March 14. The newspaper placed second in the Best Newspaper category, and its website — www.theallstate.org placed third for Best Homepage.

APSU's student newspaper was the only public university in Tennessee to garner an award from the conference competition.

Last spring, the newspaper also earned 10 awards from the Southeast Journalism Conference's Best of the South competition and two national Pinnacle Awards from College Media Association's (CMA) Fall National Media Convention.

# Beef Cattle Show Team WINS NATIONAL CHAMPIONSHIP

The University's Beef Cattle Show Team is barely older than the livestock it shows, but the program has quickly made a name for itself as a competitor on the local, state and national levels. They only reinforced that reputation when Ruby, the team's prize heifer, was named Reserve Division Champion Percentage Simmental at the 2017 Dixie National Livestock show held in February in Jackson, Mississippi.

In addition to multiple local and state championships, Ruby is the team's second national championship heifer. In 2014, the program won its first Dixie National championship when a heifer, Dreamy, was named Senior Calf Champion Percentage Simmental.

The recent national championship was the culmination of months of work

## LEADING THROUGH EXCELLENCE

## APSU THRIVING UNDER NEW STRATEGIC PLAN

On a warm afternoon in March, several members of Nashville's business elite mingled inside the Music City Center, discussing a state school 40 miles north in Clarksville. These men and women, dressed in professional attire, had just enjoyed a meal during the Nashville Business Journal's 2017 Best in Business Awards Luncheon, and as waiters refilled coffee mugs and water glasses, a few of these attendees brushed crumbs from their phones and googled, "Austin Peay State University."

Throughout the luncheon, they'd heard plenty about the schoolfrom its growing enrollment to its efforts in downtown Clarksville's revitalization—and they wanted to learn more about the University that had just been named the region's best nonprofit.

"This award demonstrates that leaders across our state are beginning to take notice of what we're accomplishing at Austin Peay," APSU President Alisa White said.

The University's recent success is the result of its adherence over the last few years to an ambitious strategic plan that calls for guiding APSU's evolution through the year 2025. The "Leading Through Excellence" Strategic Plan was unveiled in early 2016 with the five goals of growing enrollment, enhancing student success, sustaining University growth, expanding diversity and broadening communication, and after only a year into the process, Austin Peay has made significant progress toward fulfilling those goals.

## **GOAL 1: ENROLLMENT**


In August 2016, 1,900 freshman students arrived for the fall semester, making them the largest freshman class in APSU history. Another record-setting class arrived in Fall 2017, helping push APSU toward its enrollment goal.



## **GOAL 2: STUDENT SUCCESS**


Last year, in an effort to improve student success, the University joined a national higher education project known as "Foundations of Excellence." The project, sponsored by the John N. Gardner Institute for Excellence in Undergraduate Education, is helping APSU faculty and staff redefine the first-year college experience at Austin Peay.

Research has long indicated that new students who are successfully integrated into college are much more likely to succeed. This year, the campus community will begin implementing first-year experience recommendations from various stakeholders across campus.



## **GOAL 3: SUSTAINABILITY**

In January, the University Advancement Office moved to the Jenkins Building on newly purchased land along College Street, and Austin Peay is now working with Barnes & Noble to relocate the campus bookstore to a renovated, 13,000-squarefoot building on that property.



## **GOAL 4: DIVERSITY**

Increasing diversity continues to be a priority for the campus community, and last year, minoritystudent enrollment grew to more than 34 percent of the total student population. Last fall, Dr. Rex Gandy developed a Diversity Task Force to identify and explore successful methods for the recruitment and retention of minority faculty members.



## GOAL 5: COMMUNICATION, BRANDING, STRATEGIC PLANNING

This summer, the Austin Peay brand received a major boost when the University unveiled its new www.apsu.edu website. The University also increased its number of donors this year with more than 4,000 gifts totaling more than \$3.6 million to Austin Peay. In April, as part of Austin Peay's 90th anniversary, the APSU Office of Advancement raised more than \$148,000.

## **OUTSTANDING SERVICE**



#### **JOE SHAKEENAB ('04)**

A 2004 graduate of Austin Peay State University, Joe Shakeenab is a passionate builder of young adults, especially in the area of character development. Through his business, Shakeenab Consultant Services, Shakeenab uses the insightful sessions of engagements and continued interactions to groom the current and next generation of leaders. He conducts training sessions for growth to elevate

individuals, organizations and aspects of the community.

Former U.S. Special Forces, Shakeenab served 20 years with the 5th Special Forces Group as a Green Beret. During his military service, he traveled extensively to the Middle East and the Horn of Africa, training others in order to facilitate better opportunities.

Shakeenab continues to serve both Clarksville and APSU in a number of roles, including serving as president of the APSU Military Alumni Chapter and vice president of the APSU National Alumni Association. In these roles, Shakeenab has led a number of initiatives, including the creation of two endowment scholarships, the Military Alumni Chapter Scholarship and the CSM(Ret.) Sidney Brown Scholarship, at \$25,000 each over a three-year period. Shakeenab also has served as vice president of the Montgomery County Veterans Coalition, as well as chair of the advisory board of L.E.A.P. Organization Clarksville.

Shakeenab earned a master's in strategic leadership from Austin Peay in 2014.



#### **DAVE LOOS**

Known as the "Dean of the Ohio Valley Conference" during his 27-year coaching career, Dave Loos retired as head coach of the APSU men's basketball team following the 2016-17 season, leaving behind countless memories — both on and off the court.

The winningest coach in APSU and OVC history, Loos accumulated 420 victories at Austin Peay to go along with four OVC Tournament

championships, five OVC Coach of the Year honors, four NCAA Tournament appearances and six 20-win seasons. Only the second coach in program history to lead Austin Peay to both an OVC regular season title and an NCAA Tournament berth, Loos finished his 31-year coaching career with 502 victories.

For more than 16 years, Loos helped APSU thrive off of the court, serving as the University's athletics director in addition to his coaching duties. Stepping down from the position in 2014, his dual role garnered Loos respect both on and off campus. He applied the same common-sense approach to his athletics director's duties that have been representative of his APSU basketball tenure. To honor his achievements at the behest of several longtime basketball supporters, then APSU president, Dr. Sherry Hoppe, named the basketball floor Dave Loos Court. Loos was inducted into the Austin Peay Athletics Hall of Fame in February 2008.

## **OUTSTANDING ALUMNUS**



### STEVE HARMON ('83)

Steve Harmon is editor of Morning Read, a golf newsletter that targets over 1 million golf industry insiders and consumers. In his role, Harmon steers the editorial direction of the newsletter, as well as manages a network of freelance writers. Before joining Morning Read, Harmon served as deputy editor and later as editor of Golfweek Magazine from 2007-16.

From 1993-2007, Harmon served in a number of positions with the Orlando Sentinel, including senior desk editor, senior desk chief and news production editor, a position he held from 1998-2007. In that role, Harmon supervised a 40-person universal desk that edited and designed more than 50 news, business and feature sections weekly. A veteran news writer, Harmon has worked for a number of newspapers, including the Cincinnati Post, the Winston-Salem Journal, the Asheville Citizen-Times and the Kentucky New Era. Harmon got his start in sports journalism at APSU, serving as sports editor for The All State for three years.

Harmon graduated from Austin Peay State University in 1983 with a bachelor's degree in political science. A three-year letter winner ('80-'82) on the Govs men's golf team, Harmon was a member of the program's 1979 OVC championship team.

#### TRENT CAFFEE ('11)

Trent S. Caffee is a senior trader with the Dorado Trade Group, a full-service trading group focused on physical metals trading by making a two-way market in all major gold, silver, platinum and palladium bullion products. Prior to that, he worked with Elemental Capital as a trader of precious metals. An accomplished

football coach, Caffee

has worked in a number of positions for a number of programs, including a stint as quarterback coach at Austin Peay State University from 2011-12. Caffee continues to mentor and train young, multi-sport athletes in the Dallas, Texas area, having coached wide receivers and special teams for two Texas high school programs, as well as serving as a wide receiver coach for USA Football's U-16 team.

A four-year letter winner for Austin Peay State University, Caffee was a 2010 team captain for the Governors, as well as an Ohio Valley Conference Offensive Player of the Week and a two-time Athletic Director's Honor Roll member. As a student, Caffee was a founding member and officer of the Alpha Tau Omega fraternity. Caffee graduated from Austin Peay in 2011 with a bachelor's degree in health and human performance. He currently lives in Fort Worth, Texas, along with his wife, Ashly, and their four children.



#### JOHN SWIGART ('00)

John W. Swigart is the president of Spartan Chemical Company Inc., a recognized leader in the formulation and manufacture of sustainable cleaning and sanitation solutions for the industrial and institutional market. Swigart graduated from Austin Peay in 2000 with a bachelor's degree in marketing.

Swigart began his

career with Spartan in 2000 as an area sales representative working with distributors in Clarksville. He was quickly promoted to distributor relations manager, working his way through the company before being appointed to Spartan's board of directors in 2007. In his current role, he is responsible for the development and implementation of the company's strategic direction. He also serves as president for Spartan do Brasil, Spartan's wholly owned subsidiary in Campinas, Brazil, and works closely with the company's international affiliates.

Passionate about advancing the professionalism and success of the cleaning industry, Swigart has held various leadership positions for the industry's principal trade association, ISSA, including board appointments. #### MIKE KRAUSE ('07)

Mike Krause was appointed as the executive director of the Tennessee Higher Education Commission and Tennessee Student Assistance Corporation by Gov. Bill Haslam in August 2016. Prior to assuming this role, he served as the founding executive director of the Tennessee Promise and Drive to 55, where he coordinated the launch of the nation's first free community college program and an array of other programs focused on increasing the state's higher education attainment.

During the Tennessee Promise launch, he led work to build an entirely new outreach structure for 74,000 high school students, prepare a financial aid pipeline to support disbursement of \$33 million annually and traveled tens of thousands of miles across the state to ensure students and communities understood the opportunities that lay ahead. Krause previously served as the assistant executive director at the Tennessee Higher Education Commission.

Serving eight years in the U.S. Army and Tennessee Army National Guard, Krause completed three combat tours with the 101st Airborne Division and was awarded the Bronze Star Medal during Operation Iraqi Freedom. Krause earned his bachelor's degree in public administration from Austin Peay State University in 2007.

## THE ALIEN **Dreadnought**

APSU College of STEM prepares students for tomorrow's jobs

**INSIDE** the massive, sparkling white facility, a sign offers a grim warning: "Please don't give them any more reasons to overthrow mankind." The notice, hanging near the production floor, is referring to the giant robots—Wolverine, the Beast and Iceman—and the need to keep dirt particles and other debris from causing them to malfunction.

These machines, named after comic book superheroes, work alongside some 200 other robots at Tesla Inc.'s Fremont, California, facility or what Wired Magazine once called, "the car factory of the future."


Every year, thousands of college students hope to get an internship at the famed electric car company, with the jobs usually going to individuals from top-tier institutions. But last year, Austin Peay State University physics student Jonathan Bunton decided to show the Tesla executives that Austin Peay is just as good at preparing students for this type of high-tech work.

"A lot of times, some industries get hung up on finding interns from big names like M.I.T. or Cal Berkley, but I knew that I just needed a chance to show that students, who are just as skilled or more skilled than any other candidates, don't have to come from those massive, well-known schools," he said. "The interview process was stressful, but they asked questions about my research work, and I was able to go into detail about what I've done over the past year."

Bunton's research background impressed the hiring committee at Tesla, and he spent three months this summer at the Fremont facility as an intern in the company's quality engineering department. But he is not an anomaly at the University. Rather, he is an example of the type of student Austin Peay's newly named College of STEM—Science, Technology, Engineering and Mathematics is now producing. In the last few years, the College (formerly the College of Science and Mathematics) has retooled its focus to better prepare students for the high-tech realities of the 21st century workplace.



Science Foundation grant to explore possible substitutes for crystalline materials in computing, optical technology and other modern applications.

## **AN ALIEN Dreadnought**

Earlier this spring, hundreds of German-built robots arrived at the Tesla factory to help with production of the company's Model 3—a more affordable version of its popular electric car. The robots are part of CEO Elon Musk's vision of an automated factory that looks like something from a science fiction novel. In a conference call with investors last year, he said, "(When) our factory looks like an alien dreadnought, then we know it's probably right."

But this isn't simply Musk's vision. According to the Boston Consulting Group, "the share of tasks performed by robots will rise from a global average of around 10 percent to about 25 percent across all manufacturing industries." APSU will provide individuals to design and later operate many of those robots thanks to two College of STEM programs—mechatronics and the new Bachelor of Science in Engineering with a major in engineering physics. *A*

## APSU GEOGRAPHY PROGRAM EXAMINES GLOBAL ENVIRONMENT AND DEVELOPMENT

ast summer, Dr. Christine Mathenge, Austin Peay State University associate professor of geography, sat on a rocky cliff at an ancient religious site in Kisii, Kenya, and stared at the meager, metal roof homes that glimmered in the valley below. In addition to those homes, she saw several large boulders that could be used to create an elaborate economy of expensive flooring tiles, ornate sinks and carvings and sculptures, but the area's landowners have yet to tap the value of the rocks dotting their landscape.

"They sell large chunks of rock cheaply, yet it could really be a larger part of their economy," Mathenge said. "I'm interested in land ownership and land laws in Kenya and East Africa in general. I'm interested in giving landowners more control."

Mathenge began a collaborative research project that could lead to the development of a ceramic tile lab at a nearby university, thereby increasing the value of the rocks (soap stone) that dominate the area. Her work could ultimately transform the lives of thousands of people living in Kisii, but it also forms the basis of a unique degree program she oversees within Austin Peay's Department of Geosciences. For the last few years, Mathenge has served as the lead faculty member for the department's global environment and development concentration. The program's curriculum provides students with an understanding of the geographic, economic, historical, political and philosophical issues surrounding human society's interactions with the natural environment.

"The concentration's cluster of classes are designed to give the students exposure to the global environment," Mathenge said. "By the time students graduate, they're graduating into a global job market, and they need to be prepared, regardless of what their individual interests are. They have to understand how the global





economy works and how other cultures interact with and preserve nature."

Studying abroad is a key component of this concentration because Mathenge believes students need to witness the environments and cultures firsthand. In the summer, she takes a group of students to the Central American country of Belize where they develop research projects based on their encounters.

"We want to get students connected to the world outside of Clarksville," she said.

## STUDENTS SPEND SUMMER PURSUING PASSIONS THROUGH **INTERNSHIPS**

When Cassidy Graves graduated from Austin Peay State University in May with a bachelor's degree in communication, she quickly traded in her monocle for mouse ears.

That's because in June, Graves relocated to Florida where she joined Disney as a full-time, professional intern with the House of Mouse's Talent Acquisition Communications team. As a communications team member, Graves was tasked with showing prospective hires what life is like at Disney, spotlighting the company's culture and environment through its various social media, blog and digital media channels.

"Disney is a major brand, so they were only looking for candidates who already had a lot of experience and exposure to social media platforms like Twitter, Instagram and Facebook," Graves said.

The opportunity came at the right time for Graves who said she had been reaching out to potential employers for an opportunity to work with their social media teams. While Graves noted she would have considered any chance to begin her career, she understood that the chance to work with Disney represented a lot more than a line on her resume.

"I've been going to Disney World at least once a year since I was about three years old," Graves said. "It's our vacation destination as a family; last year, I went twice. We love it there, but never in a million years did I think I'd actually get the chance to work there...when they called to tell me they were offering me the job, yeah, I started crying on the phone. The woman even said 'You know, you're the second person I've made cry in an hour." The job is a perfect fit for Graves who spent the past two years working with Austin Peay's Office of Public Relations and Marketing as a social media assistant, creating photo and video content that shaped the University's social media identity. In fact, it was that wealth of experience, Graves said, that gave her an advantage over an extremely competitive field.

"I don't think I'd have gotten this position without my time at Austin Peay," she said. "They wanted someone who could shoot photos, record and edit videos and someone who had a real knowledge of social media and branding."

An amateur filmmaker, Graves said she intended to study film, but the experience representing Austin Peay opened her eyes to social media's real potential.

"I think what I really enjoy more than anything about social media is the human relations aspect," Graves said. ## **SARAH ESKILDSON**

On April 25, 2015, an earthquake ravaged parts of Nepal, destroying homes and businesses and killing nearly 9,000 people. In the months following the devastation, several mysterious individuals appeared in the rubble, offering survivors the opportunity to pursue a better life through education or jobs overseas. Thousands of women and girls, having no alternative, accepted these seemingly generous offers.

According to a 2016 report by Public Radio International, many of those women and girls were then "sold into a global network that includes the dance bars of Kenya, the brothels and underground organ clinics of India, 'paper marriages' of South Korea and China, home-cleaning services in the Middle East, slave labor in South Asia and smuggling rings at the Mexico-U.S. border."

A year before the earthquake, in 2014, more than 13,000 Nepalese women and children were victims of human trafficking, and police in that country believe that number has increased by at least 15 percent since the earthquake.

In 2006, Free For Life International, an anti-trafficking nonprofit, was founded in Nashville, and this summer, Austin Peay State University student Sarah Eskildson worked to help Nepalese women and girls as part of her internship with the organization.

"This is my passion, and I'm excited to be just a little part of something so big," she said.

When Eskildson, a Clarksville native, first enrolled at APSU, she had difficulty settling on a major. Nothing seemed to fit her interest, but one afternoon, she happened to read an article on human trafficking.

"That caught my attention, so I started researching it more," she said.

She read articles and books, traveled to Nashville to volunteer with groups, such as End Slavery Tennessee, and organized public awareness campaigns. When it came time to pick a major, she decided to pursue areas that fit this new interest.

"I remember taking the intro to sociology class and realizing this would impact my understanding," she said. "I also love to write, so I decided to major in both sociology and journalism."

Free for Life International, in collaboration with the Peace Rehabilitation Center, operates border monitoring stations along Nepal's borders with India and Tibet, and in 2015, the organization rescued 213 girls from slavery and counseled more than 1,700 Nepalese on the dangers of trafficking. This summer, Eskildson used the skills she acquired during her studies at APSU to assist these missions.

"I will be writing a lot of survivor stories," she said. "When they rescue a victim, I will write up a story to publish on the website and on social media. I'm excited I'll be bringing awareness to this issue."

Eskildson returned to campus this fall, and she plans to graduate in December. When she leaves APSU, she hopes to find a job that expands upon her experiences as an intern.

"It doesn't matter how much you're getting paid," she said. "If you love it, you're going to be happy. And this is my passion."

One recommendation of Healthier Montgomery, created by County Public Health Director Joey Smith, is the formation of neighborhood walking groups to encourage engagement and accountability.

# A Million **Extra** Years

Health director looks to prolong life in Montgomery County

On sunny afternoons, Joey Smith ('99), director of the Montgomery County Health Department, can occasionally be found on Austin Peay State University's Clarksville campus. While most people are there to study or teach, Smith's motivations are a bit more abstract. He spends his downtime at the University campus because he enjoys watching people who dream big.

"I look around, and I see people who truly believe that they'll do something big when they leave here," Smith said. "I'll walk through campus or sit at the coffee shop in the student center and listen to conversations, but I always see people who are doing things to better themselves because they're moving toward a greater goal.

"That's what I'm trying to do for my community; I'm trying to help this community move toward something greater."

For Smith, that "something greater" is a number—a very large number—but one he believes is achievable.



By the time I retire, I want to be able to say that I helped the people of Clarksville-Montgomery County live a million extra years. If I'm able to help every person live just three extra years, you're already at 900,000 extra years of life collectively.

Neighborhood gardens, like the Victory Gardens at APSU, are another recommendation of Healthier Montgomery.

As interns for the Healthier Montgomery program, APSU students Aaliyah Burroughs and Rachel Alfred work with Joey Smith on street marketing initiatives. "By the time I retire, I want to be able to say that I helped the people of Clarksville-Montgomery County live a million extra years," Smith said. "It's hard to get your mind around that number, but the way our community is growing, we could be at 300,000 people by 2030. If I'm able to help every person live just three extra years, you're already at 900,000 extra years of life collectively.

"What if you had three more Christmas mornings or three more birthdays to share with your children or grandchildren? That's what I hope I can say we accomplished by the end of my career."

## Partnering with APSU

To achieve his goal, Smith has enlisted Austin Peay faculty and students in a number of projects geared at improving lives in this area. For the past five years, he has worked with Dr. Patty Orr, APSU professor of nursing, to address what both saw as an alarming reality. After looking into incidents of breast cancer in the area, Smith and Orr discovered that Montgomery County ranked 88th out of 95 counties in Tennessee for breast cancer incident and mortality rates.

"We surveyed the data, and it was really bad in Montgomery County for underserved populations," Orr, who also occupies the APSU Lenora C. Reuther Chair of Excellence in Nursing, said. "They were being diagnosed when it had progressed too far."

Those findings prompted Orr and Smith to submit a grant proposal to the Greater Nashville affiliate of Susan G. Komen for the Cure to help fund breast health education and services to underserved populations in this community.

For the fifth year in a row, the Nashville Komen affiliate has awarded the grant to the two organizations, providing more than \$200,000 in that time for free mammograms and breast exams.

## WILCOX ATTENDS UNIVERSITY OF KENT

On a sweltering afternoon in Tallil, Iraq, a U.S. Army soldier named Elizabeth Wilcox ('17) paused on her way to the gym to examine what looked like seashells on the desert floor. Centuries ago, the Euphrates River had flowed through the area, surrounding a nearby stone structure some scholars believe was the Tower of Babel, but that channel of the river had long since turned to dust.

"Today, it's a desolate desert," Wilcox said. "There were no signs of large bodies of water nearby. I knew the history of the place, but the shells brought to life this history."

In that moment, Wilcox became curious at how geology can reveal history's lost secrets. Now, her curiosity is taking her to the United Kingdom's prestigious University of Kent, where she'll study Roman History and Archeology.

Wilcox's application received a boost last spring when she won the Classical Association of the Middle West and South's (CAMWS) Dr. Peter Knox Award. The prestigious \$2,000 award, named for the former president of CAMWS, is presented each year to one undergraduate student, one graduate student and one teacher. Wilcox, the undergraduate winner, used the monetary award to attend an excavation field school in Romania. She spent six weeks during the summer learning how to use ground penetrating radar while she assisted the excavation of the Roman site.

Hundreds of students from some of the top archeological programs in the country applied for the CAMWS Award, but the awarding committee was impressed by Wilcox's proposal to conducting phosphorus analysis of the site's soil.

"The thing about Liz is she had a very specific interest in the discipline, so I thought she stood a better chance," Dr. Tim Winters, APSU classics professor, said. "But still, that's a lot of students at a lot of top universities applying. I'm impressed. I'm very proud of her."

When Wilcox left the army after 14 years of service, she enrolled at Austin Peay with the intention of studying biology. But then she took a Latin class and "fell in love" with the subject. "Reading Virgil and Cicero made me fall in love with the culture and love it more," she said. "And then I went to Greece last summer with Dr. Winters."

During her weeks in Greece, Wilcox met some of Winters' close friends, including Dr. Guy Sanders, director of The American School of Classical Studies in Athens' excavation at Corinth.

"I never thought anything like this would ever happen," she said. "I would have to say the classics program—Dr. Winters, Dr. (Stephen) Kershner, Ms. (Mary) Winters—was such an asset to my learning here."

## **ORTON ENROLLS AT CAMBRIDGE**

In certain academic circles, Dr. Simon Keynes, Elrington and Bosworth professor of Anglo-Saxon history at the University of Cambridge, is considered a "rock star." In addition to being the great-great-grandson of Charles Darwin and the grandnephew of economist John Maynard Keynes, the renowned professor is a member of the British Academy and a fellow with the Royal Historical Society. As a scholar, he isn't easily impressed, but earlier this year, Keynes was intrigued enough by recent Austin Peay State University graduate Brittany Orton's ('16) research that he agreed to take her on as a graduate student this fall at Cambridge.

"He's a rock star of Anglo-Saxon history," Orton said recently. "The opportunity to study under him will be amazing."

Her acceptance into the nearly 800-year-old university is the realization of a lifelong goal—a goal she never expected to achieve. As a precocious eight-year-old, Orton became fascinated with medieval history. She thought of becoming an archeologist, but her lack of motivation in high school almost stopped her from one day attending a university that existed during the medieval period.

"I almost didn't graduate high school because I failed too many classes," she said. "I went to college at 18 and failed out of that."

A few years later, after marrying a U.S. Army soldier and having three children, she ended up earning her associate degree in Alaska. Then, when her husband was reassigned to Fort Campbell, Kentucky, she suddenly found herself living near a university with strong history and language programs. Orton enrolled at Austin Peay and decided to take a Medieval England course taught by Dr. Cameron Sutt, associate professor of history.

"In my last year here, I fell in love with Anglo-Saxon history," she said. "This is from the 5th century to the 11th century. My family has ties with the Anglo-Norman people, but I'd never heard anything Anglo-Saxon until last year."

Orton, a history major, began taking all the classes taught by Sutt, APSU's resident medievalist.



"She's a wonderful student," Sutt said. "She got it. She knew what the main points were, understood the significance. When I was writing the recommendation for her (for Cambridge), I thought, 'she just might have a chance at this.""

Last year, Orton, who has never traveled overseas, applied to Cambridge's one-year graduate program in Anglo-Saxon history. The key to getting into the exclusive school, Sutt said, is to get one of its renowned professors interested in your research project. Orton submitted her application, hoping that Keynes would like her topic, "Queenship in 9th century Wessex." She then waited to hear back, periodically checking her application status online.

"I was at the gym getting ready to do my thing, and I thought, 'I'll just check it," Orton said. On her cell phone, she saw an offer for admission into Cambridge. "I freaked out. I didn't have anybody to tell, except the gym people, and they just stared at me."

## MEN'S BASKETBALL'S NEW ERA

APSU lands motivated new coach

Att Figger, Austin Peay State University's new men's basketball coach, spent much of his childhood obsessed with coaching legends Vince Lombardi, Joe B. Hall and Paul "Bear" Bryant. In 1993, Figger took his first step in a lifelong journey to follow the lead of these legends when he became an assistant coach at Wabash Valley Junior College in Illinois. He took the job while still a college student himself at Pikeville College. "I felt like it was the chance of a lifetime to pursue a dream I'd always had, which was to be a basketball coach," Figger said. "It was a chance to quickly figure out if I wanted to pursue that deal."

But pursuing a dream isn't always easy, as Figger soon learned. On busy days, he'd leave the house at 5 a.m. to drive international students around the county, and he wouldn't return home until midnight. In 1994, he took an assistant coaching job at Vincennes College in Indiana, but the new post came with a small caveat—he had to complete his degree.

"There was one year where I lived basically in a warehouse," he recalled.

"I had a mattress, a microwave and a shower. It was very humbling, but it made me more hungry to pursue my dreams."

While coaching at Vincennes and pursuing a degree at Eastern Kentucky, Figger worked as a custodian from seven at night to three in the morning after practice. During his last semester, he took a class that was 250 miles away.

"There were days where I'd only get two or three hours of sleep, then make a 500-mile round trip," he said. "The adversity turned me into the man I am today."

He earned his Bachelor of Science degree in 1995, but he continued to work as an assistant coach at Vincennes. One day, while attending the University of Florida's individual camps, he encountered a gangly, intense coach from Miami High School named Frank Martin. The duo struck up a friendship, with Figger eventually coaching five Miami players at his next assignment with Odessa Junior College in Texas. When Martin became Kansas State University's head coach, Figger joined his staff. In 2008, that team made it to the NCAA Tournament's Elite 8.

"I think Frank looked at us as kindred spirits because nobody gave us anything," Figger said. "His high school coach pushed him toward college (at Florida International) and even then, Frank was working jobs and coaching JV basketball and taking

classes on the side. Whether we knew it or not, like people bond together, and I think that's what started our journey."

In 2012, Martin was named head coach for the South Carolina Gamecocks, and Figger followed his friend east. In the spring of 2017, the Gamecocks made their first Final Four appearance, dispatching powerhouse teams like Marquette, Duke, Baylor and Florida along the way.

A few weeks later, Figger was named APSU's new men's head basketball coach.

"Sometimes, I catch a moment—five or 10 minutes—and I sit back and think, 'Wow, this is really happening' or 'That really happened,'" he said. "I've been blessed to be a part of that phenomenal run at South Carolina and then to be only the 12th head coach in Austin Peay history is a blessing in itself.

"I wouldn't want anyone else's journey. I think we all have our own paths, and maybe mine has taken a little longer than I'd like, but it's prepared me to be the best person I'm capable of being at this moment in time."

And Figger sees his job as a continuation of his most important roles in life—being a devoted family man.

"I want to be known as a good husband and father, someone who's about family and who knows what his faith is," Figger said. "When my time is done as a coach or as a human being, I want to be known as someone who tried to help young men accomplish things in their lives that they may not have been able to accomplish on their own.

"I just want to make sure our players know I love them and care about them as people. My job is to help them become grown men, to help kids coming from a troubled past or maybe didn't have a great situation growing up, and teach them how to become a father, become a parent. I want to be about life." *A* 

### GLEASON ON GOLDEN SPIKES WATCH LIST

In his finest season as a Governor, senior Dre Gleason did something no one else in the history of Austin Peay baseball has accomplished—earning a spot on USA Baseball's Golden Spikes Award Midseason Watch List.

A first baseman from O'Fallon, Missouri, Gleason has long been a dynamic presence in the middle of the APSU order, but reached new heights last season. Entering the Ohio Valley Conference tournament, he led the Govs in hitting (.338), RBI (54) and walks (34) to go along with 11 home runs, 13 doubles and a .441 on-base percentage.

The 2017 Golden Spikes Award winner was named June 29 in Los Angeles, California, where the finalists and their families were honored at the Rod Dedeaux Foundation Award Dinner at the Jonathan Club.





### BANKS, YANES GARCIA EARN OVC PLAYER OF THE YEAR HONORS

A pair of Austin Peay standouts garnered recognition as OVC Player of the Year in their respective sports, with Tearra Banks (women's basketball) and Lidia Yanes Garcia (women's tennis) taking home the conference's top athletic honor.

Banks earned the nod thanks to a dominant senior campaign that saw her average 19.3 points and 8.0 rebounds and shoot 60.5 percent from the floor. As the three-time OVC Player of the Week, Banks reached the 1,000 career point mark in December and made another little piece of APSU history in the Feb. 4 game against Tennessee State, going a perfect 11-for-11 from the floor against the Tigers, equaling Gerlonda Hardin's single-game shooting record.

Yanes Garcia's two-year Austin Peay career has now included two OVC Player of the Year honors—a year ago, she became the first player in league history to earn Freshman of the Year and Player of the Year in the same season and backed that up with a 14-2 sophomore campaign that included a perfect 9-0 mark in league play at No. 1 singles.



### TIASHA GRAY CONTINUES BALLING OVERSEAS

Although she's left the hardwood of the Dunn Center behind, Tiasha Gray is still dominating on the basketball court.

In her first professional season with the Swedish club Mark Basket, she led Basketligan Dam in scoring (24.3 points) and steals (3.6) per game, also pulling down 7.5 rebounds and dishing out 5.4 assists per contest. She led Mark Basket to the Damligan playoffs, and her squad reached the quarterfinal round.

Gray will take her talents to Israel, where she signed a three-year deal with Bnot Hertzeliya with team options for 2018-19 and 2019-20. She joins a squad which lost to the eventual Israeli champions, Maccabi Ashdod, in the semifinals of last season's playoffs.



### TRIO OF TRACK AND FIELD STANDOUTS FOR THE NCAA EAST PRELIMINARY

Austin Peay track and field was well-represented at the 2017 NCAA Track and Field Championship East Preliminary in Lexington, Kentucky, with Savannah Amato, Chancis Jones and KayInn Pitts earning qualifying marks.

This is the seventh consecutive season Austin Peay has sent at least one athlete to the regional round and the second time in three seasons the Govs have equaled the program record with three athletes earning qualification.

Amato, a pole vaulter, earned her third straight gold medal in OVC Championship competition and qualified 37th overall and seventh among sophomores. Jones made her second career regional round in the long jump after leaping a career-best 20' 1.5" at the OVC Championships, earning the bronze medal in the event. Pitts qualified in both the long and triple jump for the second time in her Austin Peay career—she's the only student-athlete in program history to accomplish that feat and done it twice—in 2015 and 2017.

### What is a charitable gift annuity?

### How does a charitable gift annuity work?

In exchange for an irrevocable gift of cash, publicly traded securities or other assets, the APSU Foundation agrees to pay one or two individuals a fixed annual income backed by the resources of the APSU Foundation.

The minimum age to establish a gift annuity is 65. If you are using interest from CDs or dividends from other investments to assist in your living expenses, a gift annuity may be an option as the rate of return in greater than a CD and provides tax benefits.

Your income from a charitable gift annuity will never decrease, nor can you outlive it. This one-time purchase can provide a stable annual income and make a difference in the lives of APSU students.
