Dr. Maria Cronley asked if the departments involved are aware of the changes? Dr. Benita Bruster explained that she was not sure but would assume this had been discussed and would double check.

Dr. Maria Cronley also asked if they why the PSYC 3200 was being removed? Dr. Benita Bruster explained that as the state was changing the licensure requirements there just wasn't enough room to keep all of the courses and remain within the constraints of the number of credit hours required for degree completion. The PSYC 3200 content is covered across other courses.

Dr. Manisha Gupte asked why there was not an Introduction to Biology course in this? Dr. Benita explained the Biology is in other places just not replacing the PSYC 3200 requirement.
